## Notice and Consent for Transfer of Data out of China 数据转移通知及同意书

The Company (current employer, prospective employer, or housing provider where I have applied) has asked a third party service provider, ClearStar, Inc. ("ClearStar"), 5955 Shiloh Rd East, Suite 104, Alpharetta, GA 30005, to process one or more background screens about you which involve data transfer from China to another country.
